Passenger Cancellation Policies: No charges other than the non-refundable initial service fee/deposit are levied for individual passengers canceling up to 150 days prior to the commencement of Jet Vacations LLC services.  -30 days after reservation: A service fee of \$300 becomes non-refundable.
